The FD report, submitted by Chief Rooker, was reviewed. They are asking permission to buy a new thermal imaging camera, which costs approx. \$3500 and to purchase two sets of turnout gear at the cost of approx. \$7000 to replace out-of-date gear. No other questions arose. Motion was made to give permission to purchase a new thermal imaging camera and two sets of turnout gear by Trustee Girvin.

Motion seconded by Trustee Jump.

The Treasurer Report, submitted by Treasurer Huband, was reviewed. No other questions arose.

Mayor Wilson moved onto Vitale Paving. Mayor Wilson communicated that we could use chips money if we wanted to do more streets. A discussion was held about street paving. No voting taken at this time.

Mayor Wilson moved onto the ARPA fund. Mayor Wilson was thinking of doing more sections on the back driveway. A discussion was held around paving the back driveway.
