Mayor Wilson went over the information that was sent to us on a few different things that the tax program would consist of. Clerk Hall explained that this would benefit us for several reasons as followed.

- If our computer goes down and we back up the information, Williamson can get the backup on our computer, so we do not lose all records
- For audited purpose, we are supposed to be keeping a copy of receipt weather people would like a copy or not, the tax program will archive them, so if we ever needed to pull them
- Safer for the Village

Clerk Hall communicated that it would be easier for the Treasurer to keep track because she is manually putting all information. Clerk Hall explained that it would be an additional price to add it onto both workstations. Trustee Emerson asked if it needed to be on both. Clerk Hall explained that it would be a good idea because if the treasurer is ever out, I can look up tax information.

Mayor Wilson moved onto the tree removal quote. Mayor Wilson communicated that this is in the town but would benefit both town and village to remove it. A small discussion was held that the village would be willing to pay half if the town would pay the other half. Mark Emerson communicated that he would present this to the town board. First motion to agree if the town will do 50/50 made by Trustee Girvin Second motion made by Trustee Fenton All in favor: 5-0 Mayor Wilson moved onto reports.
