Mayor Wilson called the meeting to order at 7:00PM. Mayor Wilson asked everyone present to please stand for the Pledge to the Flag and a Moment of Silence.

Barbara Clancy asked what the issue was before anything was said. Mayor Wilson stated that it is getting worse up there on Tex Plutz. There was a small discussion on the issues arising on Tex Pultz. Mayor Wilson said that he approved the transfers to be done, so that we could input the new budget; we cannot start the new budget with anything in the negative. Mayor Wilson onto local law #4; the only change that was made was we cannot have a minimum charge. A small discussion was held about the sidewalk placements. No voting taken at this time.

Trustee Jump exited the meeting at 7:46PM.

Darrin Rooker suggested that we contact the contractor to see if they are willing to do the sidewalks, then contact the homeowner. A small discussion was held about the crosswalks. First motion to contact the contractor to see if they would be willing to do the sidewalks made by Trustee Girvin.

Second motion made by Trustee Fenton. All in favor: 3-0

Mayor Wilson moved onto waiving the fee for church street apt water/sewer hookup. They will pay for the material. First motion to waive the water/sewer hookup fee made by Mayor Wilson. No Second motion Motion failed Mayor Wilson moved onto doing a resolution to do a budget modification when ready from A599 Appropriated fund balance to the expenditure account as followed:

Since the final water read, there has been 6 gallons of water used which resulted in a water bill for the minimum water charge.

Mayor Wilson communicated that we received a quote on the generator. He stated that a year after we got the generator; they said that it was no longer around. Mayor Wilson said that he did not see a point of paying \$2224.99 for the voltage regulator if we need a new generator. After we received the quote; it was more costly than anticipated; natural gas would cost \$53716.09, and Diesel would cost \$41793.60. Mayor Wilson communicated that he just told them to fix the voltage regulator; we just paid the \$2224.99 invoice. No voting was taken.
