Corey asked who those people are who are educated enough to say they would not want it. Trustee Girvin said that we cannot do it; we do not have the funding. No voting taken at this time.

Mayor Wilson moved onto the canal day; there was a map provided that the trail will be. Mayor Wilson stated that they should have a security detail and insurance, which was provided to us.

Mayor Wilson communicated that we received a letter from Mark Emerson asking to get any contracts over to them by August or they will go by last year's budget. A discussion was held about the Fire Contract. Trustee Bell stated that it should be increased by 5%.
