At a scheduled public hearing of the Board of Trustees of the Village of Port Byron held in the municipal building at 7:00PM, the following people were present:

Mayor Wilson called the meeting to order at 7:03PM. Mayor Wilson asked everyone present to please stand for the Pledge to the Flag and a Moment of Silence.

Public to be heard.

Mayor Wilson communicated that Jay Grasso from G&G Grant was called because we may want to look for a new grant writer.

Jay Grasso gave us some background history of himself. He communicated that he started back on his own in 2014 and has 5 employees now. Jay communicated that they help communities qualify. He stated that most of their communities are small villages, which are the best. He stated that if a grant is found, you can call to see if you qualify. Jay asked what are the needs that we would like to see. Trustee Fenton stated that we would like to see a salt shed and sidewalks. A discussion was held about different grants that may be available out there; including salt sheds, playground/parks, revitalization grants, restore NY and NY forward grants. Darrin Rooker would like to thank Mayor Wilson for coming to the event that was a dedication for Tom Grasso. During the event, they used Port Byron to do a bike ride. Darrin Rooker talked about other events that may go on at the Samuel Center.

Mayor Wilson moved onto the constellation contract that will start in September. Mayor Wilson communicated that the rates are as follows:

• 12 months; .06932

- 24 months; .06876
- 36 months; .06863

A discussion was held that the prices will only be going up. Motion was made to sign the 36-month contact at .06869 by Trustee Girvin. Motion seconded by Trustee Bell. All in favor: 5-0

Mayor Wilson moved onto the Mirabito pricing quotes that will start in November. Mayor Wilson communicated that the pricing are as follows:

- 12 months; 0.435
- 18 months; 0.460
- 24 months; 0.478
- 30 months; 0.489

Mayor Wilson stated that he thinks we should go with the 24 months. Trustee Girvin stated that he thinks we should do the 30 months, this way we do not need to worry about it for a while. Motion was made to go with the 30 months at 0.489 with Mirabito by Trustee Girvin. Motion seconded by Trustee Bell.

We need to advertise with civil service for the position. A discussion was held about the DPW position and what the payrate would be. Trustee Girvin stated that we got burnt the last few times. Mayor Wilson stated that we will need someone eventually with Shane not able to drive; it would be different if he could drive.

Motion made to advertise for the DPW position by Trustee Girvin.

The Codes Report, submitted by CEO Foster, was reviewed. No other questions arose.

The Police Report, submitted by OIC Kalet, was reviewed. No other questions arose.

The Treasurer Report, submitted by Treasurer Huband, was reviewed. No other questions arose.

Motion was made to accept the reports as presented by Trustee Girvin. Motion seconded by Trustee Fenton. All in favor: 5-0

Mayor Wilson communicated that Fred Dennis asked about the debt service on the line. Mayor Wilson stated that there used to be a trailer, but when his mother passed away, the trailer was removed. Fred said that he spoke with the assessor and the code officer. Mayor Wilson stated that you cannot put a trailer there any longer. Trustee Girvin stated why can't CEO Foster write a letter to the board to clear this up. A discussion was held about the water service debt. Motion made to remove the debt service from Fred Dennis property by Trustee Girvin. Motion seconded by Trustee Bell. All in favor: 3-2

Trustee Jump and Trustee Bell voted no

Trustee Girvin asked if CEO Foster can write a letter on what he talked to Fred about.

Mayor Wilson moved onto the CCAV dinner; he went over the menu and speaker.

Mayor Wilson moved onto the certificate of liability for the canal fay committee; this shows that they are covered.

Mayor Wilson moved onto the email about veterans; you can nominate a veteran; this is for informational purposes only.
