Mayor Wilson called the meeting to order at 7:04PM. Mayor Wilson asked everyone present to please stand for the Pledge to the Flag and a Moment of Silence.

Ron Powers attended the board meeting to talk about the Christmas tree lighting on December 17<sup>th</sup>, 2022. He gave a handout of a map that the route will be and agenda. Mr. Powers would like permission to have a horse carriage ride. He said that it can hold about 10 people and will have 2 horses pulling. Mayor Wilson asked did anyone come to the board; this was the only night. Mayor Wilson informed Mark that he received the letter that was sent to him the day after the meeting occurred. Trustee Girvin communicated that he thinks that the contract should stay at \$110,000. Trustee Girvin said that the town has an obligation to provide Fire Protection for their taxpayers. Trustee Girvin communicated that we are not overcharging them. Mark Emerson stated that he will try to come to more future board meetings. Mark Emerson communicated that he hopes that next year all board members can get together about the fire contract. No voting was taken.

Mayor Wilson opened the public hearing on Local Law #6 on speed limits and stop signs on church street at 7:30PM. Mayor Wilson went over the local law.

Mayor Wilson communicated that Bims brought in the snowmobile trail along with a contact list and insurance information. Mayor Wilson stated that the trail is the same as last year.
