over an amendment to the village procurement policy that needed to be adopted and sent back along with our procurement policy. Trustee Emerson suggested that we look up the correct numbers to put in. First motion to put correct number in and adopt the procurement policy made by Trustee Emerson. Second motion made by Trustee Girvin.

Mayor Wilson moved onto re-appointing Dwight Wethey on the planning board. Dwight Term expired in 2020 and he would be re-appointed for another 5-year term.

Mayor Wilson moved onto a letter From Ronald Powers that he would like to be on the zoning board. Mayor Wilson read the letter out loud. This would be a 5-year term, which will expire in 2026. First motion to appoint Ronald Powers on the zoning board made by Trustee Girvin. Second motion made by Trustee Fenton.

Mayor Wilson moved onto conference that Sims and Applebee would like to go to on October 21st. First motion for Sims and Applebee to attend conference made by Trustee Jump. Second Motion made by Trustee Fenton.

Mayor Wilson moved onto a dinner that Judge Bell would like to attend for Cayuga County Magistrate on October 21, 2021.

First motion that Judge Bell may attend the dinner on October 21 made by Trustee Girvin. Second motion made by Trustee Jump.
